Notes from OFA Ontario Federation Agriculture

VOM in Corn Harvest


As Ontario's fall harvest continues, corn quality and the threat of moulds and mycotoxins have become a serious concern across the province. Elevated levels of vomitoxin (DON) in this year's corn crop has growers concerned about finding a market for their grain, and in some cases, figuring out how to safely dispose of crops that cannot be marketed.

Higher levels generally are being experiences in South Western Ontario but there are some hotspots with significant levels of DON in Areas east of 400 Hwy and generally closer to Lake Ontario

Mycotoxins and DON can cause serious health threats to livestock when ingested at concentrated levels. DON can also pose a serious health threat to farmers working with the infected grain if the mould is inhaled. Early field reports across the province are indicating higher than expected levels of DON and the Ontario Federation of Agriculture (OFA) reminds all farmers to work safely during the busy harvest season, especially when dealing with DON-infected corn

If corn contains low to moderate DON levels, grain cleaning with rotary screen type cleaners has been shown to be effective in reducing mycotoxin levels in the remaining grain.

The resulting high-DON screenings will be lower volume and easier to deal with than the entire grain mass.



Any farmer who discovers DON in their crop is encouraged to call Agricorp as soon as possible at 1-877-424-1300. Agricorp can discuss the best practices for handling, sorting, and if necessary destroying high DON corn as well as review the coverage available to farmers experiencing losses due to DON. OFA will continue to work closely with Agricorp and GFO to assist farmers suffering losses from DON in any way we can.

Let's be conscious of the fact that high DOM corn is an insured peril under Agricorp. Let's also be aware that this is not province wide.

As harvest winds down I wish you a safe and Happy Holiday season.



Townships are ready for the requests to make the process simple, with a small fee to cover some of the costs. Inquiries have been coming in from as far as Sudbury and it will be great to see other municipalities following this.


Road Safety is a Shared Responsibility

Need a resource that is easy to find answers to your agriculture equipment on the road. Check out this <u>Farm Guide - Farm Equipment on the Highway.</u> The Ministry of Transportation is currently working on an update to this publication and OFA is encouraging government to consult farm organizations through this process.

Every farm tractor or self-propelled implement travelling a roadway must display a Slow Moving Vehicle (SMV) sign. But most motorists don't know what the sign means, or that the SMV sign identifies farm equipment that has an equal right to travel the roadway, at a maximum speed of 40 km/hr. OFA is asking the government to improve the awareness and understanding of SMV signs through driver education courses or general awareness campaigns. Know the rules, Follow the rules, Share the rules.

The Importance Of The Internet

The info graphic below shows the use of technology on the farm and while the title is "Future Farms" much of what is pictured here is common on many farms in Northumberland County. *Smart Tractors* steer themselves. *Texting Cows* wear devices that monitor their health and movement. *Farm Data* is recorded & stored. *Drones* are looking at fields for problem areas. *Agribots* will not be far behind in the common scenery here.
