Glyphosate/Round Up Issue

Kudos to NFA for being a huge part of Northumberland County Council's decision to continue the use of glyphosate for spraying noxious weeds. NFA presented twice to County Council and also wrote letters. NFA has done a huge service to agriculture by ensuring our industry was represented during these deliberations.

Mental Health First Aid Course

Road Safety

The numbers are in and Off-Road Vehicle (ORV) fatalities are up this year. Note that

farmers, operating an ORV on the roads for farming purposes <u>must</u> wear an approved helmet. In addition to wearing an approved helmet, farmers on the roads with an ATV/ORV must insure their machine under an auto policy, the driver must be licensed (minimum G2/M2), the machine must have an Off-Road Vehicle plate, a SMV sign and, if the machine has seat belts, you must use them.

FARM 911

With farm work a bit slower in the winter, consider it a good time to get your applications in to your municipality for FARM 911 signs.



Ontario Wild Pig Reporting --- Report your Sightings!

Wild pigs are not native to Ontario and can have a negative impact on Ontario's native wildlife populations and ecosystems through predation, competition, grazing, and rooting.

The term "wild pig" encompasses any pig outside of a fence, including domestic pigs that have become wild (or 'feral') and ownership cannot be determined, Eurasian wild boar, and hybrids of domestic pigs and Eurasian wild boar.



In Ontario, wild boar are imported and raised as alternative livestock on farms for meat. While farmers are required to prevent wild boar (and other native or non-native farmed wildlife) from escaping, they may occasionally escape or be illegally released into the wild. When that happens, the wild boar must be retrieved because they pose risks to the environment and the agriculture industry.

Domestic pigs are also raised in Ontario and may occasionally escape. Domestic pigs have been known to look more like their wild boar ancestors when living in the wild and can interact and breed with other escaped pigs (including wild boar) to create hybrids.

You can help the Ministry of Natural Resources and Forestry document wild pig occurrence trends and distribution by reporting your sightings. If you have seen a wild pig or have information on a wild pig sighting, please report it on this iNaturalist page. Please include the date and time of the sighting, a detailed description of the location, the number of animals seen, and if available, include any photographs to assist in identification.


Canadian Centre for Food Integrity New Report

While there has been a significant reduction in the proportion who view the industry **negative***Iy*, this movement has coincided with an increase in the number of Canadians who report **not knowing enough** to offer an informed opinion.



Northumberland Country will use Glyphosate Northumberland County has resumed the use of

Northumberland County has resumed the use of glyphosate to kill weeds along roadside safety rails and Northumberland Forest trails. The trial of using mechanical means this past summer at an increased cost of \$70,000 was a failure according to staff.

NFA directors Doug Grey, Paul Burnham & Marty Opsteen were on board to do a presentation and talk to concerns that municipal leaders in the county had. Five of the seven municipal leaders voted to resume the use of glyphosate for 2020 with the suggestion to staff that they keep looking for other cost-effective options. Counties are required to stay in compliance with the Provincial Government vegetation maintenance standard.
