Notes from



Canada's effective national pandemic response has helped Canada's food and agriculture industries settle into a relatively stable 'new normal' operating environment, despite acute disruptions early in the COVID era. Canadian food and agricultural industries appear to have avoided many of the dire predictions made in the spring of 2020, and the largest bilateral agricultural trade relationship is functioning relatively smoothly in spite of the continued border closure. The U.S.-Canada border has been closed to non-essential traffic for months – and remains closed at least through September 21 – but agricultural trade has barely skipped a beat. Though it has provided more than \$200 million USD of

agri-food support programming, the Government of Canada largely resisted agricultural sector requests for targeted financial assistance, relying on the existing agricultural safety net and COVID-response measures open to the broader economy. The Department of Finance Canada has forecast a nearly 7 percent economic contraction in 2020, and while the long-term financial ramifications of the COVID-19 pandemic cannot yet be tallied, the Canadian food and agricultural industries appear to have avoided many of the dire predictions made in the spring of 2020.

Resi's Report of A Member Service Rep

Bill 156 Update

Beginning September 2, 2020, sections of the *Security from Trespass and Protecting Food Safety Act, 2020*, are in force to prevent persons from stopping, obstructing, engaging or interfering with livestock transportation vehicles.

At OFA, we know clear communication of the new provisions from the Ontario government to police enforcement officers and the justice system will be critical to the effectiveness of the regulations. Without their understanding and enforcement of the regulations, the risk of trespassing and harassment by groups and individuals remains high. Everyone in the agri-food sector depends on the legal system and law enforcement to protect their safety.

There is still a lot of work to be done with local police enforcement to ensure everyone is working towards the same goal of keeping our farm properties safe, and our food supply uninterrupted. OFA is committed to working on this issue on your behalf and it is a top priority for us.

Please continue to be vigilant about monitoring unwanted visitors on your farm and watching out for your neighbours.

Freedom of Information Request Update

On August 10, OMAFRA advised all three general farm organizations in the province that it intends to release the business names of FBR registrants but withhold the FBR number portion of the record. The names will be released to the person who submitted the FOI request under the *Freedom of Information and Protection of Privacy Act*.

Jointly, all three farm organizations oppose the release of this information. That sentiment was echoed by a substantial number of Ontario farmers who voiced their input and concerns to OMAFRA's Freedom of Information and Privacy Coordinator throughout the comment period. The overwhelming response from farmers was to oppose the requested disclosure of FBR information.

Going forward, OFA will officially appeal this decision on behalf of the membership, and we have been approved to do this by the Information & Privacy Commissioner. With this appeal, the release of the information is stalled. When the filing period closes for submitting an appeal, we will enter the mediation stage. If the matter cannot be settled, it then proceeds to the Inquiry Phase. OFA is committed to seeing this appeal through and protecting the privacy of farmers in Ontario.

Farm Safety and Our Family

With the increased number of kids being homeschooled and Grandparents helping out, there may be extra bodies around your farm. This is an interesting video showing bind spots on farm machinery. We all can take a moment or two to get a refresher of how to be safe.

Tractor overturn/run overs are the number one cause of injury and death on the farm. Here are some prevention tips:

- When given the option, drive tractors on the flattest possible land.
- Keep side mounted implements on the uphill side of the tractor.
- Avoid turning on slopes. Turn downhill, versus uphill, when turning is a necessity.
- Stay away from the edge of ditches and steep slopes.
- Attach hitches to the drawbar.
- Make sure tires are not frozen to the ground or stuck in mud before moving the tractor.
- Do not allow passengers on tractors.
- Check surroundings for individuals close by.






Did you know the rate of injury and death on the farm increases after the age of 70?

Common Noise Levels



A "decibel" is the unit used to measure the loudness of sound Decibel levels for each item shown in the graph may vary.

How Long Is Too Long?

The red bar shows how long it takes for a particular

sound level to become dangerous to the human ear. For example a chain saw has a sound intensity of about 109db. Without proper hearing protection, running a chain 91 dB saw for only 2 88 dB minutes can cause hearing loss! 85 dB

Clean Fuel Standard

From the Government of Canada web site: In late 2016, the Government of Canada announced that it would consult with provinces and territories, Indigenous Peoples, industries, and non-governmental organizations to develop a clean fuel standard to reduce Canada's greenhouse gas emissions through the increased use of lower-carbon fuels, energy sources, and technologies.

The objective of the Clean Fuel Standard is to achieve up to 30of annual reductions in greenhouse gas emissions by 2030, making a significant contribution toward exceeding Canada's target of reducing national emissions by 30below 2005 levels by 2030. The Clean Fuel Standard will be a performance-based approach designed to incent the innovation and adoption of clean technologies in the oil and gas sector and the development and use of low-carbon fuels throughout the economy.

The Clean Fuel Standard regulations will cover all fossil fuels used in Canada. They will set separate requirements for liquid, gaseous, and solid fossil fuels. Environment and Climate Change Canada is developing the regulations in a phased approach, with liquid-fuel regulations being developed first followed by gaseous- and solid-fuel regulations.

The Clean Fuel Standard is complementary to other climate policies and investments under the Pan-Canadian Framework on Clean Growth and Climate Change including carbon-pollution pricing. Together, these measures will reduce emissions across the economy and create incentives for innovation and clean growth.
