- Ontario's agri-food sector contributes more than \$47 billion to Ontario's annual GDP and \$112 billion to Canada's annual GDP
- Ontario farms support \$8.1 billion in annual wages and salaries
- Canada ranks as one of the top five global exporting countries with significant growth predicted to drive our production and economic contributions

Benefits for everyone

Agriculture and our rural communities rarely make it to the top of the public agenda, although the agrifood sector is one the key drivers of our provincial and federal economies.

Investing in rural communities strengthens our agri-food sector here in Ontario and across the country.
