## Hi, my name is Art Alblas and I am a byelection candidate for the OFA Director position in Zone 4 representing Elgin and Oxford counties OFA members.

I am a farmer, in 2004 my wife Sandra & I purchased our current farm just north of St. Thomas in Elgin County with the intent of establishing our beef cowcalf operation. With all the uncertainty surrounding the BSE crisis in Canada during this time, we implemented our secondary plan to develop a sheep flock, marketing lamb along with field crops including corn, soybeans, wheat and hay. Today, I am implementing programs for high health, genetics and going forward, a branded lamb direct to consumer marketing initiative.

My roots in the farming community go back to growing up on a dairy farm in Oxford County near Embro and my early involvement in 4-H successfully completing 20 projects in dairy, crops, veterinary and tractor clubs. In many cases taking on club executive leadership roles including team leader at the 4-H Provincial Leadership Conference. I graduated John Knox Christian School and Huron Park Secondary School in Woodstock before heading off to Centralia College of Agricultural Technology earning my diploma in Agricultural Business Management.

I bring to the OFA Directors role a very broad range of experience supporting crop, livestock and poultry farmers in my 40 years in Agri-business. My career allowed me to listen carefully to producers to identify and help them problem solve, find solutions, develop the strategy to improve and grow their operations. I have assisted producers in each province from British Columbia to Nova Scotia. I recently retired from my senior executive Agri-business management position that taught me boardroom etiquette along with leadership, organizational, financial responsibility, strategic thinking, communication and collaborative decision making skills.

Farmers, facing global economic uncertainty need support and our federation of agriculture has the mandate to provide a vigorous, collaborative advocacy for our members.
