Bill C 234.....Patience to Pass

Bill C234. An Act to amend the Greenhouse Gas Pollution pricing Act.

Bill C234 has been somewhat stalled at Senate at 2nd reading stage since early May. The critic who was holding things up for Bill C234 (according to Real Agriculture, was Senator Pierre D'Alphond from Quebec) has now spoken to the Bill, so the 2nd reading debate has adjourned and Bill C234 is formally referred to Committee. This is a necessary step prior to 3rd reading.

As luck would have it, the Committee it was referred to is the Standing Committee on Ag & Forestry which is

chaired by Senator Rob Black. As I write this message they are slated to meet tomorrow. There had been pressure to refer the bill to Finance & Environment Committee and that would have been a death blow.

So, it's in the hands of a friend to agriculture who has stated for the parliamentary record he sees a flaw in the bill, that it doesn't address commercial drying BUT that we should hastily pass it, in time for this fall, and deal with any gaps later.

The timelines are short for committee & third reading but not impossible it seems.

The First Official Food Day in Canada will be Celebrated this year on August 5

Twenty years after it was established, Food Day Canada officially becomes enshrined in legislation with Bill S-227, an act to establish Food Day in Canada, passing in the House of Commons.

The idea of a Food Day Canada was championed in 2003 by the late food journalist and food advocate [Anita Stewart](#) when she organized the first Food Day in response to the BSE crisis.

Senator Rob Black introduced and gathered support for the Food Day in Canada bill in the Senate, and then sought out John Nater, member of Parliament for Perth-Wellington, to sponsor the bill in the House of Commons. In passing the legislation, member of both the Senate and the House of Commons paid tribute to Stewart and also highlighted the role played by many stakeholders – from the farm gate to the food plate – in bringing food to Canadians.

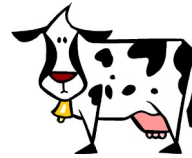

Northumberland Federation Scholarship



NFA is currently accepting application for the 2023 Scholarship Application Program.

Qualifications are as follows:

- The applicant must be a member or related to a member of the OFA within the boundaries of Northumberland County. An affiliation with a Northumberland OFA member **may** be considered based on a written description (by the member) of the applicant's involvement on the member's farm. Example: A neighbouring student that has helped on the farm and has demonstrated a passion and future interest in agriculture.
- The applicant must submit a detailed essay listing the relationship to the OFA member, his/her activities on the farm, associated memberships (4H, etc.), volunteer work, detail their course studies, and there future goals.
- The applicant must be entering the second year or greater of an accredited post-secondary diploma or degree program.
- A late application will disqualify the applicant for consideration. The applicant may reapply for consideration in the next subsequent year.
- Unsuccessful applicants may reapply
- A maximum of three scholarships will be awarded.
- A recipient may only be awarded once
- A maximum of \$3000.00 will be awarded in any one year.
- \$1000.00 will be awarded to each successful applicant.

Deadline for receipt of applications is **August 1, 2023**. The Scholarship committee will need time to read and consider all the forms and essays and make their final decision well in advance of the AGM and banquet. Please do not forget to include all the requested information and use a separate sheet to tell us about your farming connections and your community interests. Fill out an application form and include a separate sheet for additional info.
