OFA shares input on improving Ontario's privacy protection

Farm businesses in Ontario put a high priority on protecting and securing their data and proprietary information. The threat of disclosing that information poses a significant risk to the health, safety and security of farms, families and operations across the province.

In early September, OFA participated in a roundtable discussion with the agriculture industry on improving privacy protection and providing feedback to the Ontario government's proposed privacy reforms. In addition to the consultation, OFA also submitted a formal response to the Ministry of Government and Consumer Service with input and key recommendations on improving privacy protection for the agriculture industry.

OFA fully supports this initiative to address concerns and reassess the priorities for protecting private information. We applaud the Ontario government's intention to address gaps in the legislative privacy framework and to establish comprehensive, up-to-date rules that will protect privacy rights.

We believe the personal information of our 38,000 farm family members should be protected and not released without the consent of the member. It has the potential to cause severe financial loss to farm businesses through possible fraudulent use of the information by the individual collecting it or may be used to facilitate identity theft. In our written submission, OFA outlined that in the case of many farmers, as with some other business owners, their personal information is the same as their business information. Therefore, any release of business information consequently results in the release of their personal information. In these cases, we believe the business information should be afforded the same protections and privacy considerations as personal information.

OFA strongly recommends that the *Freedom of Information and Protection of Privacy Act (FIPPA)* be amended to include these protections.

OFA fully supports the proposal to increase transparency for individuals by providing them with more detail about how their information is being used by businesses and organizations; having clear consent provisions allowing individuals to revoke consent at any time, and adopting an "opt-in" model for secondary uses of their information; and giving individuals the right to obtain their data in a standard and portable digital format.

OFA looks forward to monitoring the progress of Ontario's privacy reform and working together to protect the privacy and security of our farm operations.

From farm-to-table: Bill 156 and protecting the food supply

Maintaining a steady and reliable food supply and protecting the safety of those who feed us is of critical importance. Protecting farmers, agri-food workers, animals and the entire food value chain, while respecting the right to lawful protest is balanced in Bill 156, the *Security from Trespass and Protecting Food Safety Act, 2020.* Animals rights activists' tactics have devasting impacts on the health and safety of our food supply. OFA believes Bill 156 effectively protects farm families, agri-food employees and animals from harassment while maintaining the right to peaceful, public protest.

In response to on-going and escalating interferences between activists, livestock transporters, and livestock in transit, the Ontario government proclaimed four sections of the Bill on September 2, 2020. These sections make it an offence to stop, obstruct, hinder or otherwise interfere with a motor vehicle transporting farm animals, and ensure the safety of the public, transport drivers, and animals from the risks posed by obstructing or interfering with livestock transport vehicles on our roads. The right for people to participate in lawful protests on public property remains.

OFA appreciates the support from the provincial government for demonstrating to trespassers, activists, law enforcement and the justice system in Ontario that the protection of farms, families, animals, agri-food employees and the food system is of the highest priority. Thanks to exceptional efforts from the Ministry of Agriculture Food and Rural Affairs and Hon. Minister Ernie Hardeman, farmers and agriculture organizations have been consulted in virtual sessions throughout the entire process. Local federation leaders have been invited and involved in these conversations and have witnessed the Ministry's deep commitment to see this Bill through. Particularly where policing is involved, we extend our sincere appreciation to Hon. Minister Ernie Hardeman and Hon. Minister Sylvia Jones for ensuring that the Chief of Halton Regional Police, as well as police chiefs across the province, and the Ontario Police College are all well aware and well-informed about Bill 156 in order to ensure the regulations are interpreted consistently.

The Ministry released a discussion paper which outlines proposed approaches for regulations and defines a broad range of terms related to biosecurity, food safety, human harm and animal protection zones. The paper also indicates that farmers and food processing facility owners may have the ability to define their own animal protection zone, which may be the perimeter around each building. In addition, provisions regarding false pretenses, whistleblowers and exemptions for journalists are also included. OFA continues to facilitate on-going discussions with industry partners and provincial policymakers to seek clarification and ascertain whether the proposed definitions and approaches for regulations adequately ensure the safety and security of farmers, their families and the provincial food supply.

To help address misinformation being circulated, a new website – **AboutBill156** – was developed and launched in consultation with Ontario farmers, livestock transport drivers and industry stakeholders. The website contains accurate and important information about the impact of activism on the agri-food sector and our food supply, including testimonials, biose-

curity protocols, animal care guidelines and relevant provincial legislation.

Feeding Your Future project helps farmers and food businesses fill labour gaps



The Ontario agri-food sector relies on a skilled labour force to bring our diverse range of products to market. Ontario's agri-food industry generates more than 860,000 jobs – including agriculture, processing, food service and retail.

To keep Ontario's food supply chain strong, employers along the agri-food value chain need support to recruit and train workers for in-demand jobs across the sector.

In an effort to address the workforce challenges and opportunities in the agri-food sector, OFA launched the Feeding Your Future initiative. Through the Canadian Agricultural Partnership funding, Feeding Your Future aims to help agri-food employers connect with job seekers during COVID-19 and beyond. Alongside many partners, Feeding Your Future has coordinated a job matching concierge service, nine virtual career fairs and an informative series of ten webinars for agriculture and food businesses.

The nine Virtual Career Fairs had over 1,200 participants and over 170 employers



across the province posting hundreds of positions available from June to September 2020. The webinars are aimed at job seekers and employers on various topics such as finding the right candidate, mental health and wellbeing, health and safety training, adapting during COVID-19 and encouraging job seekers to explore career opportunities in agri-food.

The job matching concierge service is free for employers in the agriculture and food sector to assist them in finding qualified candidates on AgCareers.com and CareersInFood.com platforms.
