

# **Notes from**



The Conservation Authorities act as you all know has come under to determine how best to ensure an review. OFA believes this review is needed and long overdue. The following is part of the submission OFA made to the committee on the CA review.

OFA emphasizes that the principle resource-based land use within the areas of Ontario where conservation authorities operate is agriculture. Provincially, the protection of Ontario's prime agricultural areas for their long-term agricultural use is a key objective.

Municipal councillors appointed: OFA believes that conservation authorities benefit from having board representation that is not limited to municipal councillors, but reflective of the broader interests of the watershed. We recommend that the current system of appointments to the authority board by whomever council chooses as its municipal appointment to the authority be retained.

Section 14(4): Member from the agriculture sector appointed: A further amendment to section 14(4) authorizes the Minister to appoint a "representative of the agricultural sector" to the authority board. The "representative of the agricultural sector" addresses a long-standing OFA ask; a change to the Conservation Authorities Act we welcome. However, in light of the proposed amendments to section 14.1 on the duties of members to their respective municipalities, we question what the role of the representative of the agricultural sector will be, how they will be chosen, to whom they will be accountable to and will they be a voting member? OFA recommends that the role of the agricultural representative on the board be defined, and that conservation authorities work with their agricultural community

agricultural representative is respected by their peers in the community.

Finally, we recommend that the representative of the agricultural sector be a member of an accredited general farm

organization. OFA recommends that the agricultural sector representative be a full voting member of the conservation authority's board.

Currently, the objects of a conservation authority in section 20 are, "to provide, in the area over which it has jurisdiction, programs and services designed to further the conservation, restoration, development and management of natural resources other than gas, oil, coal and minerals."

OFA recommends that the definition of mandatory programs and services be combined with a provincial commitment that ensures all thirty-six conservation authorities have the financial resources to fully deliver the provincially mandated programs and services.

OFA recommends that agricultural stewardship programs be included among an authority's mandatory programs and services to be determined under section 21.1.

As of January 7th, OFA is compiling a list of creditable members from the agricultural community to sit on CA boards to effectively address agricultures concerns at the board level.

#### **Bill 156 Proclaimed**

Security from Trespass and Protecting Food Safety Act, 2020 came into effect on December 5, 2020. This long-awaited piece of legislation will protect Ontario's food supply chain, from farm to table, without infringing on the right to peacefully

protest and, in conjunction with the *Provincial Animal Welfare Services Act (PAWS), 2019*, ensures animals are protected and cared for properly. Now begins the work of enforcement and NFA was proactive on this by meeting with a representative from the OPP earlier this fall. Directors were able to emphasize the importance of protecting our farm properties and the need for swift OPP response should there be an issue of trespassing. NFA will continue the conversation with local OPP in the new year.

#### **OFA Submission on Conservation Authorities Act**

The provincial government introduced Bill 229 on November 5. Schedule 6 of Bill 229 proposes to amend the *Conservation Authorities Act*. Since 2017, Bill 229 is the third statute to propose amendments to the Conservation Authorities Act. And before that, the government held two rounds of consultations on a review of conservation authorities in 2015 and 2016.

#### **Merged Property Titles**

In 2019, the Honourable Doug Downey (MPP for Barrie—Springwater—Oro-Medonte) introduced Bill 88 to amend the Planning Act. His Bill would allow the original lot fabric to be kept in the case of properties that merged due to the death of an abutting joint owner. Bill 88 was referred to the Standing Committee on Finance and Economic Affairs but that is where it sits. OFA encourages all Ontario farmers to write the Clerk of the Standing Committee on Finance and Economic Affairs to request that the Committee hold public hearings on Bill 88 as soon as possible, so that Bill 88 can proceed to Third Reading and is hopefully passed into law. 

#### These countries spend the least on food


ercent of consumer expenditure spent on food that was consumed at home, by selected countries, 2015


