RE: Project Proposal – Ontario Farmers’ Adoption of Best Management Practices

The Ontario Federation of Agriculture (OFA) is the largest general farm organization in Ontario, proudly representing more than 38,000 farm family members across the province. OFA has a strong voice for our members and the agri-food industry on issues, legislation and regulations governed by all levels of government. We are passionate and dedicated to ensuring the agri-food sector and our rural communities are included, consulted, and considered in any new and changing legislation that impacts the sustainability and growth of our farm businesses.

Ontario’s diverse and innovative agri-food sector is a powerhouse for the province – growing and producing more than 200 farm and food products, fuelling our rural communities and driving the provincial economy by generating more than 860,000 jobs and contributing over \$47 billion to Ontario’s annual GDP. We are the leading agricultural advocate for Ontario farmers, their businesses, and their communities.

Farmers are integral partners in managing the natural environment. They rely on the air, soil, and water to conduct their business, and have a vested interest in the sustainability of these resources. Farmers interact intimately with the natural environment every day, and an agricultural perspective to resource management is critical.

OFA championed the development the Environmental Farm Plan (EFP) program and Best Management Practices (BMPs) workbooks. OFA fully supports the stated objectives of the proposed project:

- Investigate the patterns of farmer's adoption of specific BMPs across southern Ontario.
- Analyze factors that drive the patterns of adoption of specific BMPs.
- Explore casual mechanisms that give rise to the factors driving adoption of specific BMPs.
- Produce recommendations for increasing adoptions rates of specific BMPs across southern Ontario.

This project will provide important insights into the adoption of BMPs. Increasing our understanding of key patterns and factors in the adoption of BMPs will inform policy development and program design aimed at increasing BMP adoption rates.

OFA is prepared to commit \$2,000 worth of in-kind support to this project. Our in-kind support will consist of promoting the survey to OFA members, providing feedback on research materials, adding to the interpretation of data analysis results, and reviewing draft reports.
