## Re: Meeting request to discuss Ontario agriculture and its contribution to our province's recovery from COVID-19.

On behalf of the Ontario Federation of Agriculture (OFA) and our rural communities across Ontario, thank you for launching #TakeTheMic – a grassroots-driven policy consultation to guide the Ontario Liberal Party's plan for Ontario.

OFA has a strong voice for our members and the agrifood industry on issues, legislation and regulations governed by all levels of government.
