## Farm Vehicle License Plate Review

OFA is recommending you take a look at how your pickup is licensed.

Your pickup is licensed to farm, but are the benefits worth the price to plate? "We recommend that our members - and all farmers - really look at what they use their truck for."

If the trucks are more for personal use than farm functions, it might be wise to transfer them to a passenger vehicle registry and save the \$157 farm plate cost.

When there was very little difference between farm plated vehicles and passenger vehicle validation costs, farmers just went for the slam dunk, because the benefits outweighed the cost.

In February, the Ontario government announced it would eliminate passenger vehicle and light-duty truck license plate fees and issue refunds for 2020 and 2021. Commercial or farm-plated vehicles were not included in that change.

Light-duty pickups under 3,000 kilograms are exempt, but those same trucks with farm plates are automatically placed in the next weight class (3,001-3,500 kg) to qualify for the commercial plate.

If your farm truck is used to ship inputs to the farm or inputs between the farm and different lots of acreage, or production to market, that's all commercial activity. If not it might be worth considering changing it back to a light duty truck plate.

#### **Farm Plates**

If you received a letter in the mail from MTO regarding farm plate fees that left you confused, consider reading OFA's updated factsheet, as we have tried to clarify the changes. <u>https://ofa.on.ca/resources/benefits-farm-plates/</u> We often get asked, what are the benefits of farm plates? 1. Lower annual plate cost, 2. Option to drive a D truck with a Class G Driver's License, and 3. Limited dangerous goods exemptions. It may be worth looking into whether farm plates are still serving the needs of your farm business. ### **Recent Ag Census Data**

The latest Census of Agriculture data released by Statistics Canada shows the following national trends:

• Almost 65% of farms across Canada reported using sustainable farming practices like rotational and winter grazing, planting cover crops and using shelterbelts and windbreaks, up from 53.7% in the previous Census five years ago. As well, farmers are turning to more drought-tolerant crops, like barley, which saw an increase of almost 25%.

• Over twice as many farms report they're producing renewable energy production compared to the last Census. Solar energy leads the way, showing an increase of 66.5% from 2016 to 2021.

• Farmers are using technology like automated guidance steering systems and high-tech mapping to increase production and stay competitive in the global market.

Overall, the industry showed resilience in the face of COVID-19 by maintaining, or even growing production in some sectors despite pandemic and labour challenges.

# Northumberland Federation Scholarship

NFA is currently accepting application for the 2022 Scholarship Application Program.

Qualifications are as follows:

- The applicant must be a member or related to a member of the OFA within the boundaries of Northumberland County. An affiliation with a Northumberland OFA member <u>may</u> be considered based on a written description (by the member) of the applicant's involvement on the member's farm. Example: A neighbouring student that has helped on the farm and has demonstrated a passion and future interest in agriculture.
- The applicant must submit a detailed essay listing the relationship to the OFA member, his/her activities on the farm, associated memberships (4H, etc.), volunteer work, detail their course studies, and there future goals.
- The applicant must be entering the second year or greater of an accredited post-secondary diploma or degree program.
- A late application will disqualify the applicant for consideration. The applicant may reapply for consideration in the next subsequent year.
- Unsuccessful applicants may reapply
- A maximum of three scholarships will be awarded.
- · A recipient may only be awarded once
- A maximum of \$3000.00 will be awarded in any one year.
- \$1000.00 will be awarded to each successful applicant.

Deadline for receipt of applications is **August 1**, 2022. The Scholarship committee will need time to read and consider all the forms and essays and make their final decision well in advance of the AGM and banquet. Please do not forget to include all the requested information and use a separate sheet to tell us about your farming connections and your community interests. Fill out an application form and include a separate sheet for additional info.
