Rural Infrastructure – Russel Hurst, Ontario Agribusiness Association (OABA)

- 500 members in OABA
- Strategic focus areas: member engagement and communications, stakeholder relationships, safety, training, education and leadership, advocacy & government affairs and organizational excellence
- Labour is a significant issue across the sector
- Fertilizer challenges have been difficult to navigate
- 5 key priorities from Ford government; infrastructure being one of them
- Four key issues:
 - Transportation. Need long-term infrastructure improvements. Government works with local municipalities to identify key areas to improve
 - Energy
 - Labour
 - Focus on comprehensive sector strategy that addresses chronic labour shortages. Attract new skilled entrants to the sector
 - Showcase the benefits of living in rural Ontario
 - Connectivity
 - Agri businesses need to have connectivity to operate their businesses in the new digital economy
 - Connectivity is now an essential infrastructure

Other pieces

 Environmental protections, pandemic preparedness, agriculture research, health care, red tape reduction within government, coordinating with multiple layers of government

Municipal Engagement - Danielle Sharman, Policy Analyst, OFA **Ag Matters Guide**

- One page document to highlight key agricultural issues taking place at the municipal/local level – synthesized from the 40-page version
- Provides an overview of issues affecting farmers today and identifies opportunities for local communities to support this untapped, and sometimes undervalued, economic sector
- Some new topics have been added ready to share components with new elected officials and staff at local municipalities

- Every municipal election, OFA produces a kit for county and regional federations
- The kit is complimentary to the Ag Matters Guide and provides key messages, questions to consider asking at All Candidates Meetings, and a sample letter for candidates. Not for distribution but provides sample wording to use in outreach.

Rural Infrastructure - Municipal Engagement Marcus Ryan, Mayor, Zorra Twp.

- Ag is an economic safety net for our community. As long as we protect lands, they will always be productive
- We don't maximize opportunities in agriculture that could boost economic development
- What does that look like:
 - Distributing economic development policy, don't put all eggs in one basket to ensure an economic safety net
- Building affordable communities
 - o Affordable housing farmhouse severances what's reasonable?
- Affordable and safe food
 - We need a robust food system
- Internet
 - $_{\circ}$ $\,$ It has become essential in all locations. In the tractor, in the barn, etc.
- Need to maintain infrastructure to maintain and grow rural communities
 - Not receiving enough funding for hospitals, schools, etc.
 - Recognition that smaller scale services are
 - Responsibility of municipalities roads and bridges, recreation
- Joint lobby efforts are needed; The healthier agriculture is, the more robust and sustainable a strong economy can be
